

Matters reported

Notice of Commencement of Period for the Exercise of Public Rights

The Authority must provide for the exercise of public rights as set out in the Local Audit and Accountability Act 2014 (Sections 26 and 27) and the Accounts and Audit Regulations 2015. The Regulations require the Authority to approve and publish the Annual Governance Statement and the Accounting Statement alongside a Notice of commencement and a Declaration of status of accounts to allow it to commence the period for the exercise of public rights so that it includes the first ten working days of July.

The Authority is therefore unable to demonstrate that it made proper provision for the exercise of public rights in 2015/2016. In our view, the response to Assertion 4 on the Annual Governance Statement should be 'No'.

In future, the Authority must ensure that the Annual Return is approved and published to allow for the proper provision for the exercise of public rights in accordance with the Regulations and proper practices.

Other matters not affecting our opinion which we wish to draw to the attention of the authority.

Internal Auditor's Report

The internal auditor answered "yes" to test F regarding petty cash payments. The correct response is "not covered" as the Parish Authority does not hold any petty cash system. The Authority should ensure that the internal auditor's report is reviewed before sending the document to the external auditors. The Authority should minute this process. If there are any errors in the report it should either be amended by the Internal Auditor or the Authority should provide an explanation for the error.
