- 6. Minutes of previous meeting 729 being a true reflection of that meeting were approved and signed by the chair. Proposed Cllr Southcott, seconded Cllr Andrews, supported by six councilors.
- 7. Correspondence Cllr Colin Dunn tendered his resignation, a long standing member of the council chairing the council through some difficult times whilst also seeing through important initiatives such as the recent Wig Wag lights. A vacancy is now available for Marystow parish. Letter of appreciation to Mr & Mrs Copper for their continued services to the community from the beginning of the pandemic. It was resolved to support the draft letter and to give a card and £25 voucher. Proposed Cllr Dawe, seconded Cllr Vanstone.
- 8. Councillor reports: Cllr Vanstone informed that the east bound wig wag light could have been positioned further east so that it would not be as near to the hedge. Contractors left surplus spoil from the installation. Cllr Vanstone was concerned at the amount of bank/hedge removal for the development opposite the school. Cllr Crocker concerned with the amount of thefts from farms and business in the parish's, she raised the question of re-establishing the 'Neighbourhood Watch', Cllr Southcott suggested that the Police initiative 'Neighbourhood Alert' had been set up and
